Letter from the Bishop of the Oregon Synod ELCA

January 11, 2023

Dear Friends and Members of the Oregon Synod,

My prayers are with you as you welcome the new year, dwell in the glow of Epiphany, and gather together to plan for your 2023 congregational meeting.

The life and vitality of your faith community are important. The work we do together as the Oregon Synod is important. And, our unity as the Evangelical Lutheran Church in America is important.

- 2. Karen noticed that we need a larger amount for participation in the Oregon Synod meeting since it is projected to be in person and needs to cover lodging. Prior amount in previous years was \$1500.
- 3. \$18,953.79 left from the 2021 Payroll Protection forgiven loan will be applied to the deficit for the 2022 budget.

Motion: Ryan Burghard moved to accept the proposed budget with an increase to item GB 804 for conventions to \$1500 and a transfer of \$20,000 from line item 909.1 (Pastor salary) to 909.4 (Pastor housing). Seconded by Karen Anderson. The motion carried.

Minutes of the Special Congregational Meeting of November 13, 2022 Purpose: Piano Purchase

Meeting: Bethel Lutheran Church Special Congregational Meeting

Date & Time: November 13, 2022

Location: Zoom and In Person at Bethel

Special Congregational Meeting Sunday 13 November 2022

Minutes

The meeting was called to order by Congregational President Ryan Olson at 11:17 AM. A sign-in sheet for voting members was passed for signatures. The meeting included 22 voting members with 20 participating in person and 2 online.

Motion by Ryan Burghard on behalf of Council: I move to authorize Bethel congregation to spend up to \$12,000 to purchase a new (to us) piano using existing memorial funds. Motion seconded by Don Worthington.

Discussion points:

The piano currently used in the sanctuary is over 100 years old. Tuners cannot rescue tuning any longer. Current piano belonged to Bethel member Willa Baldra and was donated by Merle Baldra after her death.

Karen Anderson: Memorial funds to be applied to piano purchase include those dedicated to the memories of Joyce Hansen and her brother A.B. Ludviksen (approximately \$11,000 for the two funds). All family members support this use of memorial funds. We have additional funds in undesignated memorials.

Scott Burris: What kind of piano and where will it be purchased? Bethel musician Shlomo Farber has checked pianos available at Portland retail shops. Jamie Vandenberg and Shlomo are willing to help us find a suitable piano.

Chris Siems: Are we confident that \$12,000 is enough?

Karen Anderson: We can accept designated donations that to use toward the piano purchase.

Ryan Burghard: Purchase would likely include moving new piano into the sanctuary and moving and disposal of old piano.

Ryan Olson: Could we receive any compensation for old piano? Possible, not likely!

Holly Redfern: Removal of old piano might cost \$1,000. Should we bump up amount authorized for piano purchase?

Based on these discussion points, Ryan Burghard accepted friendly amendments to his original motion and Don Worthington affirmed his second to the amended motion.

Amended motion: I move to authorize Bethel congregation to spend \$12,000 to \$15,000 to purchase a new (to us) piano, with up to \$12,000 coming from memorial funds and up to \$3,000 from designated giving. Motion passed by voice vote.

Pastor: recall we received \$50,000 from our siblings at St John Lutheran. Invites people to be part of the discernment team to recommend use of these funds. Gift given in spirit of outreach and with no restrictions or designations. Interested parties should contact Pr. Leon LaCross. The meeting was adjourned by Ryan Olson at 11:38 AM.

Report from the Worship & Music Committee

2022 brought with it more adventures as we fully moved back to worshiping together while also maintaining "remote" services for our members. We added communion back into the worship services and moved into a more normal worship format.

The new year brought with it an upgrade to our technology in the sanctuary, adding a mini-PC as well as other tech to fully connect our remote service to the church sound system. This allows us to fully connect Pastor, the musician, and the other microphones without a separate USB mic setup. In 2023 we look to possibly moving around our camera setup, and perhaps a newer microphone for capturing the congregational sound as we sing!

For the first 9 months of the year David Tafone was our musician, but in continuing Bethel fashion transition was in the air and David moved on from Bethel. After a few months of Friends of Bethel helping us out we were once again blessed with Shlomo Farber joining us full time as our new Bethel Musician in November. A truly seasoned professional, we are very grateful to have Shlomo join us and bring his classical and jazz repertoire to our worship.

Perhaps the biggest event for Worship & Music was a wonderful Christmas gift as we purchased a "new to Bethel" piano! While many of us never realized how *cough*unique our old piano sounded, once we had the new piano in place it became very clear how wonderful the new sound was!

Remote worship will continue to be an integrated part of Bethel's worship format into the future. Even as things become more normal and we worship together, the value of remote worship has become very apparent to continue accessibility to all our members. For me personally the beginning of 2022 brought affirmation as to why this is so important due to the loss of one of our beloved members, Carolyn (Stretch) Beck. While Stretch was not able to join us for worship in the last year due to covid and other personal limitations, she was able to join us virtually every Sunday and for happy hours. I will forever be grateful that we were able to be deeply connected to Stretch all the way until the Sunday before she passed, without the blessing of virtual worship we would not have had this opportunity for continued relationship.

Report from the Property Management Committee

With all that happened last year, the major subject has been water yet again. We have had outside water coming in and inside water going out. The usage of the church in the last year was very minimal as most activities were limited to the pandemic.

Limited usage of the building has reduced the normal amount of repairs needed for the facility, but there is some change on the horizon.

Last year we did have the normal issue of water entering the basement when we had extreme heavy rainfall of over 2 inches in a day. The gutters had another cleaning, but this may change somewhat with the removal of the trees on the property to the south of the church. We will keep on having the gutters cleaned, but we will look at what changes will occur with the new dynamics.

The big project for the year was the installation of the grease interceptor to reduce our impact on the sewer system as well as reduce our need to have the sewer line repaired from clogs on the system. We expect the new system will take some time to get used to, but the benefit of not having the sinks and floor drains backing up will be an enjoyable result.

We also had a failure of one of the hot water heaters. This is expected to be replaced before the Bethel Play takes place this year. Currently the second hot water heater can supply the church with hot water as needed.

In general, it is expected that problems will arise as the building is more heavily used. The building committee will try to stay on top of issues as needed.

A big thank you to Nash for being at the building and being the eyes and ears on the place for the last few years and helping to keep the committee informed on issues as they have happened. I also want to say thank you to Tana and Scott for the help that they have given in

keeping up on the needs of the church.

Report from the Youth Drop-In Center

Bethel Neighborhood Youth Drop-In Center: Report to the Congregation January 22, 2023

Program Overview: Bethel Lutheran Neighborhood Youth Drop-In Center is restarting its Summer Day Camp for elementary school students in North/Northeast Portland OR. After a pandemic-forced suspension, we are back for 2023—our 27th season. The Center is a partnership among Bethel Lutheran Congregation and neighborhood families, offering a safe space for children to learn, play, make friends and have adventures in the community. While housed at Bethel, the program is secular, offers no religious instruction, and welcomes children of all backgrounds.

The Big Picture: The Center seeks applicants for Director and Staff positions for the 2023 Summer Program. The job is posted on Craigslist and on student job boards across metro Portland. The application form and job description are linked to the Drop-In page of the Bethel website https://bethelpdx.org/summer-program/. Now we need your help—both in finding great matches for the Director and staff and creating strong connections with neighboring families and households.

Background: Thanks to space shared by sister congregation Peace Lutheran, the Drop-In Center moved the Summer 2019 Day Camp Program off-campus because Bethel had suffered significant flood damage earlier that summer. In May 2020 we set aside our plans for the Summer 2020 Day Camp Program since the pandemic risk was too great. The Summer 2021 Program was also cancelled as Bethel congregation struggled with continuing COVID concerns.

Summer 2022 seemed possible, though we did not get as early a start on planning and staffing as we usually do. We advertised, networked, contacted neighbors and friends, and coordinated with other programs, but could not find a director or other staff. We offered a competitive wage but had no qualified applicants. Summer 2023 shows great promise as neighbor families want a strong Summer Program and our target audience for Director recruitment has largely recovered from the stresses of the 2021-2022 academic year. Onward!

Financial Support: We have combined carryovers from Summer and After School Programs of about \$35,000. We anticipate camp fee income of about \$2250 (assuming enrollment of 15 children at lowest fee tier of \$25 per week) to \$3750 (assuming enrollment of 25 children at lowest fee tier). We have also recently received a grant of \$4000 from the Youth Guidance Association (YGA) in support of the Summer 2023 Program. YGA continues to be a generous benefactor of the Drop-In Center, as have intrepid individual donors and the Bethel Players.

Ministry Report: Angel Project

The Bethel Angel Project provided gifts and food to seven families and three adults. We also sent small Christmas gift cards to two families and four adults with long connections to Bethel. The project received contributions of cash, gift cards, gifts, food, paper goods, cleaning products, gift bags, handmade blankets, warm hats (many hand crocheted), gloves, help with wrapping gifts, shopping for and packing food and assembling 125 bags for Neighbors Helping Neighbors from at least 30 individual Bethel members and Friends. We are grateful for the many ways our church community has reached out to provide some joy and comfort during the holidays to our neighbors.

All these contributions to the Angel Project make it possible. Remember, blue bags are available at church for recycling cans and bottles with the proceeds going to the Angel Project. You can drop off full bags at Church.

Initially, the group discussed having an available pantry for people to walk by and help themselves with their needs. Some of us had seen examples in the neighborhood. This is still a possibility with a donated pantry from St. Luke Lutheran. In addition, we researched what other groups and churches are doing.

Research:

• Lisa Siems found that *Arbor Lodge Shelter* could use some prepared meals for 40-50 individuals.

- Stephanie Acevedo served at local pantries, NEFP and visited churches and other sites and reported on that.
- Several of us visited churches like St Andrew's who for many years, once a week gives boxes of food to families. Most of which are supplied by private donations and Oregon Food Bank. St Andrews actually has a hired organizer who tracks, organizes, places orders on what they give away in order to keep a balance of stock on hand to give. They also have a dedicated space for housing food supplies.
- All Saints has hot meals to go on Saturdays and they have a shower van one day a week.
 St Francis serves food daily as well as a clothing shop that offers three free pieces of clothing. Woodstock has a food panty for its neighborhood.
- Joann Noll and I found St Johns Food Share had donated to the Angel Project in December. They also committed to letting us shop for what we needed to prepare meals.

We decided to plan, prepare, and cook meals, i.e., entree, fruit or treat and perhaps a drink once a month and then deliver on a few Saturdays. We did this from June through October, the Dates listed below at which time *Arbor Lodge* closed for renovation and had their people moved to other residences until the renovation could be completed by approximately March of 2023.

• July 23rd: 60 people

• Aug 6th: 60 people

• Aug 20th: 50 people

• Sept17th: 40 people

• Sept 24th: 40 people

Oct 8th: 40 people

The Bethel Bees also held an evening BBQ on Aug 12^{th,} 2022, potluck, and game night in the Bethel Parking lot. Karen Anderson cooked delicious hot dogs and hamburgers. Several Bees made flyers to invite the neighbors and passed them out. The turnout was very positive and all had a good time.

Stephanie Acevedo found *Community Dinners PDX*, which has seven locations where they serve shared meals to build community. Mark Seger works diligently to organize, prepare, and serve meals at all locations once a month, who could not be kinder or more generous. Beginning in October, the Bethel Bees went to Renaissance Commons to serve food and then sat down and share company with those who came. Through the first months for 2023, we will continue to serve and share at Renaissance Commons on the third Thursdays until March. In March 2023, we will test-drive our Bethel kitchen to see if it works to prepare food for Renaissance Commons sites. We will serve on Thursday, February 16 at 5:00 at 2133 N Argyle

Council Resolution on Retiring Parsonage Debt:

Resolution from Council

Approximately \$48,000 remains owed on the Parsonage Remodel Loan. Paying off this loan would reduce our 2023 expenses by about \$16,000 per annum by eliminating the mortgage payment, the unrelated business income taxes, and the tax return preparation fee.

Therefore, Council resolves to pay off the Mission Investment Parsonage Remodel Loan using Bethel funds from the following sources:

- \$26,866.01 Zero out Flood Repair Fund (never transferred for loss of use)
- \$17,450.00 Reduce Parsonage Remodel Reserves (leaving approximately \$2000 for contingencies)
- \$4,000 Borrow approximately this amount from Bethel reserves in the short term and repay this amount through fundraising

Copyright Solutions 525: Do we need both? One License has a streaming/podcast option for an additional \$80. Note: substitute musicians are paid under the Music Director personnel; guest musicians paid under DGB fund. Checking with CCS on what they cover.

5707 Elevator: Set aside for eventual expense.

5709 Parsonage MIF Loan: \$1123 a month from this line. Additional \$200 monthly from designated parsonage fund. In this budget we are assuming payoff on January 30, so need to leave January payment in.

5800 Administration

5801 Office Supplies: Sundays & Seasons = \$350 (lectionary plus other material for preparing bulletins). Copy paper, other supplies - \$400? 5802 Office Equipment(Copier): Current month's usage plus pay off the loan we made to ourselves to buy the machine. Monthly service contract + color copies runs \$125-150 a month. We need to pay ourselves back about \$2400 before we start accumulating for an eventual replacement. \$150 per month covers service contract, but won't make a big impact on the "loan". 5803 Postage: Leave as is

5804 Conventions: Pastor, 2 delegates = \$900. No hotel this year. Bishops Convo + lodging \$500

5806 Property Tax: Close to last years, just adding a pad

5807 Insurance: ...ouch. So rounded up...

5808 Miscellaneous: Not sure where else to put charge for background checks

5810 Bank charges: Vanco costs about \$30 a month; Paypal is 3%. Adds up...

5811 Computer & Virtual Worship

5811.6 Software: Zoom, MSFT, Adobe, Quickbooks, Quicken. We cancelled the high powered Adobe In-design program that Summer could use, but nobody else could. The one we have lets us make PDFs – seems to be required.

5811.7 Adding a line for a couple hours of local tech support (No line for computer equipment – do we need one?)

5812 Staff meetings: Can we make this meetings/appreciation (i.e., gifts?) 5813 Bookkeeper: Might need a little consultation to get Budget set up...we'll see.

5814 Unrelated Business Income Tax: Fed/state/city tax that we pay for having the parsonage rented while it has a mortgage. These go away if the loan is paid off. I think it will go down a little because the amount of the debt goes down. \$750 tax preparation.

Designated Funds – What are they?

Designated GB are categories related to a General Budget expense line. They may or may not persist from year to year.

- They may be a "set aside account" where we know that the bills for this category arrive irregularly and often in a large amount. For example, the property insurance bill arrives in November and this year cost over \$10,000. To even out expenses over the year we transfer 1/12 of what we've budgeted from the General Budget into this "set aside account" each month. That way there isn't a giant leap in expenses in November and we have a truer picture of what it costs to run the church month to month. These funds generally start and end at zero.
- They may be a "savings account" like Capital Projects or Elevator.
 These let us save up for expenses that we know will happen but not necessarily when. For example, we'll draw on the Capital Projects

- fund to pay for the new water heater that we'll need. Again, this avoids wide month to month variations in General Budget expenditures.
- They may reflect designated giving by individuals. For example, someone may wish to fund a particular church maintenance expense or designate a gift for special music. These gifts can cover general budget expenses that weren't specifically budgeted for.

Designated Non-Budget. These do persist year to year.

 These are special projects that we don't budget for. For example, Bethel Players income and expenses, Youth Drop In, Special Events (like buying Easter lilies, etc), Parsonage Remodel, Flood damage.

Memorials

 Gifts received in honor or memory of someone. These funds persist from year to year. As a rule of thumb, we honor the wishes of the family when spending these funds—for example, Joyce Hansen and AB Ludviksen funds were used to purchase the new piano. If funds have been on the books for more than a year and the family hasn't indicated their wishes funds can (but don't necessarily have to) be transferred to undesignated memorials.

Grants

 Grants to the congregation that are often restricted to certain uses, like the food ministry. We also occasionally receive unrestricted grants (Synod). Note the Youth Drop In grants are not recorded here since they are made to that organization, not the congregation.

Thank you for getting all these reports in. It takes a village.

Included is the recipe for Karen's Mac & Cheese which you will be enjoying during the Annual Meeting.

- ½ lb uncooked elbow macaroni , about 1 ½ cups
- 3 tablespoons butter
- 2 tablespoons all-purpose flour
- 1/2 teaspoon salt
- 1/8 teaspoon ground black pepper
- 1 1/2 cup milk, any kind
- 2 1/2 cups shredded cheddar cheese

Instructions

Preheat the oven to 325 degrees and lightly grease a square baking dish.

Cook the macaroni to al dente, according to package instructions. Drain and set aside.

Melt the butter in a medium saucepan over medium heat. Blend in the flour, salt, and pepper. Cook for 2 minutes.

Slowly add the milk and half and half, stirring constantly, and cook over medium-low heat for a few minutes until the mixture is just barely thickened. Remove from heat and stir in 1 cup shredded cheese, stirring just until melted.

Add the cooked macaroni noodles and toss to coat. Pour half or the pasta mixture into the prepared baking dish. Sprinkle ½ cup cheese over the top. Add remaining pasta and sprinkle with remaining cheese.

Bake for 15-20 minutes or until cheese is melted on top.
